Report of Positions:

<u>PRESIDENT:</u> Due to a recent increase in solicitors throughout Amber Meadows, the Board requested a member of the OP Police department meet with members to discuss possible solutions and what activities qualify as a violation of city code. The following is the information learned from this meeting:

- The number one way to ward off solicitors is to have an Official city of Overland Park," No Solicitors" sign posted on or directly near the front door (Front door or side door windows are best) The Neighborhood used to have "no solicitors" signs posted at Subdivision entrances, however they have gone "missing" Unfortunately the Police officers informed the board that general signs such as those do not have legal standing against solicitors.
- If you have a "No Solicitors" sign posted and you are still having visitors, do not answer the door and immediately contact the **NON EMERGENCY** police hotline **913-895-6300** the quicker you are able to contact the police the better chance they have of locating the individual responsible.
- PLEASE contact the **NON EMERGENCY** if you notice any suspicious activity within the subdivision - The Police department keeps a 90 record of incidence reported, so even if you report a minor action, they might be able to link that to an incident reported at a later or earlier date.
- Resident of Overland Park can request a FREE Security Assessment of their home from the OP police department. They provide suggestions on crime prevention through environmental design. Call 913-895-6300 if interested
- The Police department also provides free mediation for neighbor disputes or disagreements. They will work closely with the Codes department to determine if any city codes have been violated and/or put you in contact with the proper department.
- The number crime with Overland Park subdivisions is Car Thief Always roll up your windows, lock your doors, and keep valuable items out of sight
- There will be "No Solicitors" signs available at the Pool on July 4th or you may contact the city for instructions

VICE PRESIDENT:

• Monument Lighting - We have been having difficulty with maintaining lightening at the monument on 128th and Neiman - After investigation it appears the wire was accidentally cut and has been fixed

TREASURER:

- Currently on budget awaiting invoices from Pool maintenance
